6. Based upon my review of Creighton's internal records and documents, no documents exist in response to the Subpoena that would reflect that Lisa Kay Monnet, DOB: 06/22/1964, (a/k/a Liza Guzman, Lisa Suzanne Monnet, Elizabeth Suzanne Guzman, Lisa W. Guzman, and Lisa J. Whatley) took any classes at Creighton University or otherwise received any degree from Creighton University.
